3.	I understand that if my child misses practices/games this may affect his/her playing time.
4.	I will make every effort to have my child at games within the time requested by the Head before start time.
5.	I am responsible for the behavior of my invited guests to ensure my guests understand the GHAA and County rules and regulations.
6.	I will remain off the fields during practices and games unless I am provided with a valid ID from County and cleared by the Head Coach only to be on the field.

8.	In any event that I or any of my invited guests refuse to follow directions or exhibit aggressive or unsafe behavior, they will be removed from the area immediately and the athlete will be subject to disciplinary penalties.
9.	I will not coach from the sidelines, either during practices or competition. I will let the coaches do their job.
10.	I will abide by the "24 hour rule" which means not speaking to your coaches about the game or your child's playing time within 24 hours after a game. I will always address issues I have in a calm and professional manner in a
